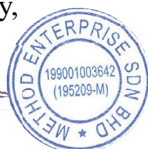
The foregoing warranty is exclusive and in lieu of all other warranties, expressed or implied, including but not limited to warranties of merchantability or fitness for a particular purpose.

In addition, in no event will METHOD be liable, in breach of warranty, contract, tort, strict liability or under any other legal theory, for any indirect, incidental, consequential, special punitive and/or exemplary damages, losses or expenses or loss of profit, revenue or date, regardless of whether purchaser was informed about the possibility of such damages, and in no event will METHOD's total liability exceed an amount equal to the sales price of the product giving rise to the liability.
